The following sections and attachments in IFB WAN & Phone Line Bid 2024 have changes or additions:

Scope of Work Section 2.1.8: Added requirements that the vendor must be able to supply analog telephone services at MSPD sites that are currently using VOIP Services. Section 2.1.8 now reads as follows:

2.1.8 The contractor must deliver local telephone service as FXS analog telephone to MSPD PBX phone systems as required. Offices in Appendix A noted as having VOIP services must have local telephone services offered as FXS analog telephone lines as well.
