# HOW TO: Establish Paternity



# What does it mean to establish paternity?

Establishing paternity is a very important step in the legal processes involving families and child support. Establishing who the biological and legal father of a child is impacts many things:

- <u>Child Support:</u> Before deciding how much money the dad needs to give for the child's needs (child support), we have to be sure who the dad is.
- <u>Custody and Visitation:</u> Who gets to take care of the child and visit them is also decided based on knowing who the real dad is. Dads have certain rights and responsibilities.
- Inheritance: If something happens to either the child or the dad, knowing who the dad is becomes important for deciding who gets what from the other.
- Medical History: Knowing who the dad is helps us get the full medical story of the child, which is important for taking care of their health.

## Ways to establish paternity

- Genetic Testing
- Paternity Affidavit
- Court order

## **Genetic Testing:**

If someone needs to figure out who the biological dad is, they can get free paternity testing through the Family Support Division. This test, also called DNA or genetic testing, involves gently rubbing a Q-tip-like swab inside the cheek of the child, the mom, and the potential dad. After that, these swabs are sent to a lab for testing. If the results show there's at least a 98 percent chance that the man is the dad, according to Missouri law, he is considered the presumed father.

But it's important to know that just having the genetic test done isn't enough to legally say who the dad is. To make it official, parents need to fill out an Affidavit Acknowledging Paternity or get a court order naming that person as the child's father.







## **Paternity Affidavit**

The Affidavit Acknowledging Paternity is an important paper that needs careful attention. Before completing it, one must listen to certain information spoken aloud, known as oral notice, which is explained in the Notice of Rights.

If the Affidavit is being filled out at the hospital during the child's birth, the hospital staff will provide the necessary information.

If the affidavit is being completed after the birth certificate has been filed, the agency that gave the form will give the required information.

## **Paternity Affidavit Forms**

- Father's Affidavit Acknowledging Paternity
- Husband's Denial of Paternity
- Mother's Affidavit Acknowledging Paternity
- Rescission of Affidavit Acknowledging Paternity

The Mother's and Father's Affidavit Acknowledging Paternity, along with the Husband's Denial of Paternity (if needed), must be sent together.

All these documents must be submitted to the Bureau of Vital Records by mail.

#### **Court Order**

In some cases, the court steps in and decides to do tests if there's an argument or if someone is saying they're not the dad.

Remember, the rules and steps for finding out who the dad is can be different in different places, so it's a good idea to talk to someone who knows the rules, like a legal expert, especially where you live.
